SUMMARY OF PROCEEDINGS OF 37TH (THIRTY-SEVENTH) ANNUAL GENERAL MEETING (AGM) OF THE MEMBERS OF SATIATE AGRI LIMITED (FORMERLY KNOWN AS SHABA CHEMICALS LIMITED) HELD ON SATURDAY, SEPTEMBER 28, 2024 AT 12:00 P.M. (IST) THROUGH VIDEO CONFERENCING, UNDER REGULATION 30(2) & OTHER APPLICABLE REGULATIONS OF SEBI (LISTING OBLIGATION AND DISCLOSURE REQUIREMENTS) REGULATIONS, 2015.

The 37th AGM of the Members of **Satiate Agri Limited (Formerly Known as Shaba Chemicals Limited)** ("the Company") was held on Saturday, September 28, 2024 at 12:00 p.m. through video conferencing, in compliance with the applicable provisions of the Companies Act, 2013, the Ministry of Corporate Affairs ("MCA") circulars dated 25th September 25, 2023, 28th December, 2022, 5th May, 2022, 14th December, 2021 read with circulars dated 13th January, 2021, 5th May, 2020, 8th April, 2020 and 13th April, 2020 (collectively referred to as "MCA Circulars") and SEBI circulars dated 5th January, 2023, 13th May, 2022 read with 15th January, 2021 and 12th May, 2020 (collectively referred to as "SEBI Circulars").

At the outset, Mr. Utpalbhai Raval, Managing Director of the Company, welcomed all the Members of the Company at the 37th Annual General Meeting and introduced all the Directors, KMPs and Invitees who were present in the AGM. The representatives of statutory auditor and secretarial auditor were also present at the AGM.

Further, the Chairman then informed the members that pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, and Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), the Company had provided the remote e-voting facility to the members of the Company whose name appeared as member in the register of members as on Saturday, September 21, 2024 to cast/exercise their vote(s) electronically in respect of businesses to be transacted at the AGM for which the remote e-voting period had commenced on Wednesday, September 25, 2024 at 09:00 A.M. and ends on Friday, September 27, 2024 at 05:00 P.M., through e-voting platform hosted by NSDL.

The members were also informed that the facility for voting by way of ballot papers was made available for the members who had not cast their vote through remote e-voting. It was clarified that only those members holding shares of the Company as on Cut-off date i.e., Saturday, September 21, 2024 were eligible to participate in the remote e-voting as well as voting at the meeting.

Thereafter, the chairman read and informed the members about all the arrangements made for remote e-voting process and voting at the AGM. It was informed that CS Rupal Patel, Practicing Company Secretary was appointed as Scrutinizer to scrutinize the remote e-voting process & voting during the AGM.
