Veteran journalist Sankarshan Thakur, editor of *The Telegraph* whose prowess with words added that extra edge to his analyses and ground reports, died at a Gurgaon hospital on Monday after prolonged illness. He was 63.

Born in Patna in 1962, Thakur was the son of senior journalist Janardhan Thakur. He received his early education at St Xavier's in Patna and later in Delhi, before earning a degree in political science from Hindu College, Delhi University.

Thakur, who began his journalism career in 1984 with *SUNDAY* magazine, is survived by his wife Sona, daughter Jahan and son Ayushman.

He worked in several places, including *The Indian Express*, *Tehelka* and *The Telegraph* in two stints.

Known for his sharp political commentary and empathetic pen, Thakur was a keen chronicler of India's politics, particularly Bihar. His home state was the focus of not just his journalism but also his credentials as an author.

UNREST! Tension flared in Mandya, Maddur districts of Karnataka after stone-pelting during Visarjan in Ram Rahim Nagar

**CLASHES ERUPT DURING
GANESH IMMERSION**

Tension prevailed in the Maddur town of Mandya district since Sunday evening, after communal riots broke out during Ganesh Idol immersion procession.

The tension continued on Monday also after the police resorted to lathi charge on the protesters, who defied the prohibitory orders.

Consequently, both JD(S) and BJP leaders entered the fray, alleging police atrocities against the Hindus. Meanwhile, the police have arrested 21 miscreants, who pelted stones from the place of worship on Sunday night.

The clash began on Sunday evening, when the Ganesh Idol immersion started in the town. The police had instructed the organisers to switch off the DJ and not to stop in front of the place of worship.

The procession went through as per the police directions. However, when the procession approached the place of worship, stones started raining from the top and behind the place of worship. Many people, including the police, were injured. The police resorted to lathi charge

to disperse the mob and clamped prohibitory orders.

On Monday morning, the Hindus defied the prohibitory orders and took out a protest march. The police resorted to lathi charge, where a number of people, including women, were injured. Meanwhile, police

had arrested 21 miscreants, who had resorted to stone pelting on Sunday night.

However, the protesters were not in a mood to listen and wanted to know why they were beaten up on Sunday night, though the people from other communities pelted stones.

Superintendent of Police Mallikarjun Baladandi said police teams were deployed immediately to contain the situation and prohibitory orders have been imposed in Maddur to curb further violence

By Monday afternoon, JD(S) leader Nikhil Kumaraswamy and former BJP MP Prathap Simha arrived at the spot. Defying prohibitory orders, the two leaders organised and addressed rallies. The police had a tough time handling the crowd.

There was a war of words between JD(S)-BJP leaders. Union Minister HD Kumaraswamy said that the Congress was politicising the issue and harassing Hindus. Former BJP MP Prathap Simha charged that the Congress was implementing a "Taliban" government in Karnataka.

District in charge Minister N Cheluvayayawamy said that both JD(S) and BJP were instigating the people to resort to violence. "Soon after the stone pelting, police arrested 21 people.

However, none of them are Hindus and how the opposition is telling that we are appeasing minorities. Since they cannot face us in the Assembly, they are creating problems in the streets," he added.
